All proposers are reminded that **Enclosure F: Subcontractor Indemnification Form** must be submitted with their proposal package, regardless of whether subcontractors will be utilized.

To ensure clarity during evaluation:

- If the proposer **intends to subcontract**, the form **must be fully completed**.
- If the proposer **does not intend to subcontract**, the form **must be marked “N/A”**.
- **Any forms left blank will be interpreted to mean the proposer does not intend to subcontract and will be expected to self-perform the work** as outlined in the solicitation.

This clarification is being issued to eliminate any confusion, as the requirement was discussed during the pre-proposal meeting, which was non-mandatory.
